Parish Plan Review 2015

It is now almost 5 years since the Parish Plan was initiated and time to review progress to date and decide what direction the Parish Plan Steering Group(PPSG) take for the future. The PPSG feel that the input of those living in the community is of paramount importance.

The following pages summarise achievements to date and seek your views under four headings. We would like your responses to reflect those things which you feel would benefit the community for the future . Obviously, not all suggestions will be achievable but providing they are practical and within the scope of our capability we will give them serious consideration .

The General section of the questionnaire seeks to establish your views on the setting up of a 'Community Association'. it is envisaged that this would have charitable trust status and would be the vehicle for supporting community projects in Oldbury Parish. By having trust status the opportunities for fund raising are widened. This sort of organisation requires good management and we need to understand the weight of community opinion before taking this further.

The 2010 questionnaire expressed a desire to improve the Football Facilities at the Playing Fields. This has been investigated and it is clear that it will involve a big financial commitment which would need to be funded. It is likely to cost £100,000 with £10,000 annual maintenance cost for a good standard of pitch. A project of this nature would require a strong justification to proceed and we need to ask the question is there sufficient support to justify a new football facility.
